Manager's Report:

1) Correspondence

The Manager read into the record the resignation of Jason Hodlofski from Council. (letter attached).

The resignation of Hodlofski was accepted on a motion by Steve Lambert seconded by David Blair (with regret). The motion passed by a unanimous voice vote.

The Manager read into the record the resignation of Attorney Harold Caldwell as Borough Solicitor. (written notice attached).

The resignation of Attorney Caldwell was accepted following a motion by Steve Lambert to accept followed by a second by John Raub. The motion passed by a unanimous voice vote.

2) MINUTES –May 29, 2025 & June 13th, 2025

The minutes of the above meetings were approved following a date correction of the June 13th meeting to June 20th, 2025. Motion to approve was made by David Blair and seconded by John Raub. The motion passed by unanimous voice vote.

3) PAID BILLS – \$98,916.48

The paid bills from May 29th – June 23rd, 2025 were presented (ledger attached). David Blair made a motion to approve the motion was seconded by John Raub and passed by a unanimous voice vote.

4) Tourism Resolution

A Resolution (attached), endorsing the AMERICA250PA and their mission was presented. John Raub made a motion to adopt the motion was seconded by John Davis and passed by a unanimous voice vote.

5) Davison Green (use request)

The Chamber of Commerce requested use of the Davison Green July 19th from

5:00 – 8:00 PM for an event “Picnic in the Park” John Raub made a motion to approve the use and the motion was seconded by Chris O’Connor. The motion passed by a unanimous voice vote.

Council Agenda Request: John Raub made a motion to remove items 1-5 under Council Agenda Request. The motion was seconded by Steve Lambert and passed by a unanimous voice vote.

4. Vote to change the Borough Council President.
5. Discussion on the termination of the Borough Solicitor.
6. **Discussion on hiring an Ordinance Enforcer.** John Raub presented a framework (attached) for creation of an additional Ordinance Enforcement Officer to enforce selected ordinances. Council agreed by unanimous consent to move to special meeting with further review.

Prior to adjournment Steve Lambert informed Council that due to personal family health issues he would not be available over the next 3-4 months and therefore was resigning from Council. Council wished him and his family well and accepted the resignation by unanimous consent.

NOTE: Prior to adjournment John Raub asked that the resignation votes of Council members be held at a meeting to be scheduled. He noted that Council had 45 days to accept the resignations. Council agreed by mutual consent.
