5. Project Report/Bridges-Nothing to date – completion 2027
  - a. Mr. Davis had a question on the Prospect ST Bridge being under a grant for repairs. Boro Manager will research with PennDOT.

  - a. Grant completed and submitted. No additional info requested. Awarding of Grant expected to be announced in September/November of 2026. 2024 Grant awarding announcement pending DCED meeting, which was delayed because of delayed passing of State budget will be in January 2026.

8. Streets and Sidewalks Committee- report on mtg

- a. Mr. John Raub reported out about Chief requesting a PENNDOT study of Elmira St for designating a School Zone. Chief and Boro Manager will follow up with PennDOT to submit request. Motion made by Mr. Davis and second by Mr. Pratt.
- b. Discussion on PennDOT planning to Mill and Pave Cantons St in 2027. Discussion about water and sewer pipes under street, can we update. Time may not be sufficient. Pending LSA Grant approval and study completion may not be until 2027.
- c. Discussion on the Streets scapes trees (3 or 4) starting to push up through sidewalk. Boro Manger to research for Arborist to discover options. Trees were planted approximately 20 years with a 7-10 year plan nothing done since original planting except trimming.
- d. Motion made to purchase reflective material for traffic signs in the Boro to assist in driver awareness. Boro Manager to follow up on.
- e. Committee would like to see a bid for snow removal. Boro Manager will follow up on this.
